# From ARRL/QST:

### Hams Assist in Aftermath of October Storm

A rare nor'easter brought historic snowfall and widespread damage and power outages from the Mid-Atlantic into the Northeast United States on the last weekend of October. Up and down the Atlantic seaboard, radio amateurs provided various critical services to the National Weather Service through the SKYWARN weather spotter program, and provided communications support to local, state and federal emergency management groups.

Amateur Radio operations at the National Weather Service office in Taunton, Massachusetts were active on WX1BOX, the office's Amateur Radio station. Hams in Taunton were active for 21 hours supporting meteorological and damage data.

In Connecticut, section leaders were conducting their Simulated Emergency Test (SET) when the storm hit. "Because of the storm, we truncated the SET and braced for the unseasonable October snow," explained Emergency Coordinator Wayne Gronland, N1CLV. "The planned scenario was quickly displaced by a *real* nor'easter! SKYWARN operators across the section were activated on Saturday afternoon, and nets went late into the evening gathering snow, rain and wind data for NWS."

# President Obama nominates two FCC commissioners

President Barack Obama has nominated two new FCC Commissioners: Jessica Rosenworcel -- to replace retiring Commissioner Michael Copps, and Ajit Varadaraj Pai to fill the seat vacated by Meredith Attwell Baker, who left the FCC in June 2010.

The FCC has been down one commissioner since Baker's departure, and Copps' departure at the end of the year would leave the agency with only three commissioners: two Democrats and one Republican. Only three sitting Commissioners may be members of the same political party. At present, Chairman Julius Genachowski, Copps and Mignon Clyburn are Democrats. If confirmed, Pai will join Commissioner Robert McDowell as one of the two Republicans on the Commission.

## We have SUNSPOTS!

Sunspot activity — and good HF propagation conditions — have been building for months, and it seems we've finally hit a high spot. October was a great month, especially on 10 and 12 meters. Those who took part in the CQ Worldwide/SSB contest on Oct. 29-30 reported the DX bands opened early and stayed open late.

We still have ARRL Sweepstakes/SSB (Nov. 19-20) and CQWW/CW (Nov. 26-27) to go.

## Repeater news from Jim, K2LM:

Starting around noon on Friday Oct. 28, the 147.000 repeater's receiver on 147.600 MHz was being opened by noise. The noise was fooling the PL decoder and keeping the repeater on the air continuously.

So Friday afternoon I turned off the 147.600 MHz receiver, meaning you could not access .00 directly on 2 meters. The Spruce UHF repeater on 448.225 MHz remains on the air. The 147.240 repeater is also on the air and Echolink is also working just fine through 24.

Because of the snow storm, I have not been able to get up Spruce Mountain, but I hope that by the next club meeting I can get there and determine where the noise is coming from and see if I cannot fix the issue before winter really sets in at the site.
